The motion seconded by Ms. Bowman and passed by majority vote.

Mr. Schnitzer made a motion to re-appoint Steve Blair to serve on the Planning Commission for a term to expire on December 31, 2027. The motion was seconded by Mrs. Neff and passed by unanimous vote.

Mrs. Stoner made a motion to appoint Chuck Crone to serve on the Zoning Hearing Board with a term to expire December 31, 2026. The motion was seconded by Mrs. Neff and passed by unanimous vote.

Mrs. Stoner made a motion to appoint Kyle Schnitzer to serve as Liaison on the Planning Commission with a term to expire on December 31, 2027. The motion was Seconded by Ms. Bowman and passed by unanimous vote.

Ms. Bowman made a motion to appoint Angie Ginter to serve on the Parks and Recreation Committee with a term to expire December 31, 2028. The motion was seconded by Mrs. Neff and passed by unanimous vote.

Mrs. Stoner made a motion to appoint Bernadine Morrison to serve as the Vacancy Board with a term to expire on December 31, 2025. The motion was seconded by Mrs. Neff and passed by unanimous vote.
