

Mount Holly Springs Borough 2026 Tax Ordinance

Ordinance # 2025-04

AN ORDINANCE PROVIDING THE MILL RATE OF TAXATION IN THE BOROUGH OF MOUNT HOLLY SPRINGS FOR THE FISCAL YEAR 2026; RE-ENACTING TAXES HERETOFORE LEVIED; FIXING THE COMPENSATION OF THE TAX COLLECTOR; PROVIDING FOR PENALTY OF TEN (10%) PERCENT IN THE CASE OF TAX PAYERS WHO FAIL TO MAKE PAYMENT OF 2026 BOROUGH REAL ESTATE PROPERTY TAX AFTER FOUR (4) MONTHS OF THE TAX NOTICE; PROVIDING FOR DISCOUNT FOR THOSE WHO MAKE PAYMENT OF SAID TAX WITHIN TWO (2) MONTHS OF THE NOTICE.

NOW THEREFORE, IT IS HEREBY ENACTED AND ORDAINED by the Council of the Borough of Mount Holly Springs, Cumberland County, Pennsylvania, as follows:

SECTION 1: That a tax is hereby levied upon all real estate and all property in the Borough subject to tax of the Borough for the fiscal year 2026 at the rate of 3.5 mills on each dollar of assessed valuation as provided by law for general and other Borough purposes.

SECTION 2: That a tax as heretofore enacted is hereby re-enacted that a tax levied upon all real estate and all property in the Borough subject to tax of the Borough for the fiscal year 2026 at the rate of 0.239 mills on each dollar of assessed valuation as provided by law for lighting and illuminating the streets, highways, and other public places with electric light or other illuminant.

SECTION 3: That a tax as heretofore enacted is hereby re-enacted that a tax is hereby levied upon all real estate and all property in the Borough subject to tax of the Borough for the fiscal year 2026 at the rate of 0.341 mills on each dollar of assessed valuation as provided by law for fire protection services.

SECTION 4: That a tax is hereby levied upon all real estate and all property in the Borough subject to tax of the Borough for the fiscal year 2026 at the rate of zero (0) assessed validation as provided by the law for purpose of supporting ambulance, rescue, and other emergency medical services.

SECTION 5: That the one (1%) percent earned income and net profits tax heretofore enacted is hereby re-enacted.

SECTION 6: That the Local Services Tax as heretofore enacted is hereby re-enacted.

SECTION 7: That the above taxes shall be in addition to any other taxes properly enacted by the Borough Council, which taxes shall remain in effect.

SECTION 8: That the compensation of the tax collector shall be the same as heretofore fixed; however, for the fiscal year 2026 and for each fiscal year subsequent thereto, all taxpayers required to pay the Mount Holly Springs real estate property tax shall be entitled to a discount of two (2%) percent from the amount of such tax upon making payment of the whole amount due

thereof within two (2) months after the date of the tax notice; all tax payers who shall fail to make payment of any such tax charge against them for four (4) months after the date of the tax notice shall be charged a penalty of ten (10%) percent, which penalty shall be added to the taxes by the collector and shall be collected by said tax collector.

SECTION 9: All ordinances and resolutions or parts thereof inconsistent herewith are repealed; however, all other tax ordinances or resolutions shall remain in effect.

SECTION 10: The above taxes are enacted by authority of the Borough Code and the Local Tax Enabling Act.
