Public Comments: Katie Daniels (handouts were provided) discussed partnership with Park & Rec about yoga classes at Trine Park with Mella Luna. Park and Rec would actually be sponsorship for classes because classes are \$10 each – Dawn Tulle, the instructor, is to receive \$50 per class and anything over the \$50 will go to Park & Rec. 1-hour classes to start on Sat. – April 13, 2019 and run to Sat. – May 11, 2019. These would be rain or shine. There was discussion brought up by Annan and Lois about April 13, 2019 being a little early in the year to start these classes – because of cold weather still and rain. Lois suggested about Dawn doing these classes on her own and Borough waiving the fee for Trine Park use. It was mentioned that the picnic tables can not be moved for classes if it rains. Also, there was discussion about advertising the classes – on Dawn Tulle’s website and at her business – also putting in Borough Newsletter to see about interest. Cathy was given a sample of the contract to take to Mark, Borough Solicitor to look over.

Old Business:

3rd Subject: Holly Festival Day on Sat. – September 21, 2019. Annan questioned about getting applications and money. She has 5 applications so far for the event. Also discussion about pros and cons from vendors from past years and what changes could be made. More discussion on this at future meetings.

4th Subject: Halloween Parade. More meetings are necessary for planning this event and these meetings will possibly be in May. More discussion about these meetings was tabled for March meeting.

New Business:

1st Subject: Opening Day for Carlisle Area Little League at Butler Street Park on Sat. – April 6, 2019. Carlisle Area Little League are to be painting the dug outs and doing the field maintenance.

2nd Subject: Several committee members met with Pastor Dan Worrall from the Carlisle Evangelical Free Church. There was discussion about them volunteering their time and equipment to help with projects in the Mt. Holly Springs community. Some of these projects were discussed with Pastor Dan – like trail clean-up, park clean-up, dog park at Stoll Field and the Veteran's Park. Discussion on this was tabled for future meetings to think about what we would like them to help with.

3rd Subject: Need to change the May Park & Rec meeting because it falls on primary day – Tues. – May 21, 2019. Proper notification will be given and May Park & Rec meeting will be changed to Tues. – May 14, 2019. *OK*
